



# **TERRELL L. SCRUGGS SCHOLARSHIP**

## ***Student Application for 2021***

The Terrell L. Scruggs Scholarship honors lifetime Transylvania County resident and community leader Terry Scruggs. Terry graduated from Brevard High School and attended both Mars Hill College and Appalachian State University where he received undergraduate and master's degrees respectively. This scholarship passes on his enthusiasm and commitment to both Transylvania County and education by awarding a student or students a scholarship valued at up to \$1,500 to pay exclusively for tuition to the community college, college, or university of the student's choice.

**Scholarship recipients will be recognized at the City Council meeting on Monday, June 21, 2021 at 5:30 pm.**

**Eligible applicants must meet the following guidelines:**

- 1. Must be a graduating senior from one of the three Transylvania Co. Public High Schools.**
- 2. Applications must be typed or written in ink to ensure legibility.**
- 3. Attach a copy of your high school transcript.**
- 4. Attach a 2x3 graduation photo and sign the photo release form.**
- 5. A copy of the Letter of Acceptance from your college or university you plan to attend.**
- 6. Applications are due on or before April 9<sup>th</sup>, 2021.**
- 7. Complete the entire application. Incomplete applications will not be accepted.**
- 8. Three (3) completed recommendation forms need to be attached in sealed envelopes.**
- 9. Completed applications can be submitted in ONE of TWO ways:**
  - A. Turned into the counselor by 3pm ON or BEFORE April 9<sup>th</sup>, 2021**
  - B. Hand delivered to the Brevard City Hall by 5:00pm ON or BEFORE April 9<sup>th</sup>, 2021**
